Correct signage is displayed Rooms will be allocated as close to each other as possible to facilitate effective supervision. If groups comprise of children under 18, accompanying adults will be allocated separate rooms if requested. | |
| Security | Security Systems in place at Canberra City YHA include: - Security surveillance cameras - Electronic door swipes on all bedroom and female bathroom doors - Lockers are provided in all dormitory rooms to store valuables - Valuable storage also available in the locker room which is located on the first and second floor - Staff patrol the building | Guests must keep personal belongings with them at all times, and not leave their luggage unattended. | |
